

INFRASTRUCTURE STATUS

The drinking water supply line, water depot and waste water collector line have been completed by The Ministry of Culture and Tourism at the tourism center. 1st phase chairlift facility of 1.800 persons/hour capacity and the 2nd phase chair-lift facility of 2.450 m with a capacity of 800 persons/hour have been constructed and they are utilizable. The existing infrastructure in the settlement area such as drinking and serving water, sewage system, electrification, telecommunication, etc. might be used. Urban infrastructure services that are inefficient for the requirements or which require renovation shall be realized by the municipality, the related public institutions and/or the investors or the required financial contribution shall be made.

EXPLANATIONS AND GENEREL CONDITIONS

- 1) The preliminary permit and definite allocation processes respecting the parcel under the ownership of the municipality shall be executed by The Ministry. However, the land hiring cost and the endorsement share shall be paid to Sarıkamış Municipality. The easement contract shall be signed between Sarıkamış Municipality and the investor and a clause shall be imposed for easement at the land register.
- 2) The infrastructure operations, daily use facilities and mechanical facilities at the tourism center are being operated by Karçamtur A.Ş. Company, which has been incorporated by the Kars Governorship, Governor of Sarıkamış District, Municipalities of Kars and Sarıkamış, Youth and Sports Foundation and of which the firms receiving allocation from The Ministry have become shareholders. The new investors who shall receive allocation shall be obliged to become shareholders/members of said company by the payment of required contribution shares and dues. The definite allocation procedures for the potential investors failing to become a shareholder of the association or fulfilling the shareholder's requirements in the preliminary permit period, shall not be realized.
- 3) Applications shall be made by defining the sort and class of the facility determined within the scope of the Regulations on Certification and Qualifications of Tourism Facilities.

Total Investment Cost and Definite Letter of Guarantee Unlimited in Time have been calculated according to sort of facility by using the method indicated at the table below :

Total Investment Cost = Bed Capacity X Unit Cost According To Type of the Facility Definite Letter of Guarantee Unlimited in Time = Total Investment Cost X 5 %
