#### **INFRASTRUCTURE STATUS**



#### **OTHER INFORMATION**

- 1) Thermal water allocation possibility is subject to the "Regulation for Usage Rights and Operation Conditions and Rules for Thermal waters within Tourism Areas and Centers" published in the official Gazette dated 31.12.1993 No:21805 at the final allocation phase.
- 2) All the necessary permits shall be obtained according to the "Regulation of Thermal Springs" published in Official Gazette No: 24472 of 24.07.2001, enforced by the Ministry of Health.
- 3) Tourism center is located at a Second Degree Natural Site, thus all planning-designing processes shall be subject to the consent the Council for Preservation of Cultural and Natural Resources.
- 4) Land rental fee and shares from revenue shall be paid to Provincial Administration of Afyon. A Right of Easement contract will be signed between the investor and Governorship and the easement will be imposed at the Land-Register.
- 5) Total Area of Plot No: 287 is 45.357 m<sup>2</sup>. All the procedures for relinquishment of necessary area for public use (green areas, roads) excluding 15.750 m<sup>2</sup> of accommodation facility area, will either be done by potential investor or municipality.
